Note-1 : The cut-off marks (out of 100) in Tier-I exam would be UR-35, OBC-34, SC/ST-33 & EWS-35 (all Ex-Servicemen would be treated in their own category viz., UR/EWS/OBC/SC/ST).

Note-2: On the basis of their performance & normalization of marks in Tier-I exam, candidates would be shortlisted for Tier-II @ 10 times the number of vacancies, subject to the condition that the candidate should have scored minimum cut-off in Tier-I.

Note-3: On the basis of their combined performance in Tier-I and Tier-II, the candidates would be shortlisted for Tier-III/Interview @ 5 times the number of vacancles subject to the condition that the candidate secures minimum 33%
